

**SA HEALTH 2019 EVIDENCE TO SUPPORT TPPP RM PRIORITIES FOR APPOINTMENTS:**

All candidates are required to upload evidence of which SA Health’s priority group you are in. Only the documents listed below will be accepted – if you fail to provide relevant evidence it may affect which priority group you are placed in. You must upload this evidence with your application – additional documents will not be accepted after applications have closed. Please provide copies of original documents – the copies do not need to be certified.

In some of the categories you may be required to provide evidence of more than one document - please note you can only upload one file so if you have multiple documents you need to copy and save them as one file and then upload that file.

Where you are required to provide a valid photo identification (apart from a Passport) only one of the following forms of photo identification will be accepted: Australian Driver’s License, Tertiary student identification card, or other Government photo identification card or Proof of Age card. **SA Health will not accept** a photograph taken on your own device – it must be a photo with appropriate identification.

Please note: if you were born in Australia after 1986 of parents who were born overseas there are conditions applied by the Department of Home Affairs on Australian citizenship. If you fall within this category please check, before completing your SA Health online application, with the [Department of Home Affairs](#).

Priority Group	Evidence that will be accepted
1) Candidates of Australian Aboriginal and/or Torres Strait Island descent	<ul style="list-style-type: none"> <li>• A copy of "Confirmation of Australian Aboriginal and/or Torres Strait Islander heritage from an incorporated Indigenous organisation which is stamped with their common seal; OR</li> <li>• A Statutory Declaration that legally declares your cultural identity. The Statutory Declaration <u>must</u> be certified by an Aboriginal Justice of the Peace.</li> </ul>
2) Candidates who are permanent Australian Citizens/Australian permanent Residents/New Zealand Citizens and are either (a) a resident of South Australia applying for a position in a country or metropolitan location; or (b) live outside of South Australia and are applying for a Country Health SA site only, and live within a 200km radius from that location  <b>OR</b>  3) Candidates who are permanent Australian Citizens/Australian permanent Residents/New Zealand Citizens who live in a state other than South Australia	To confirm <u>Australian or New Zealand citizenship</u> you need to upload a copy of one of the following: <ul style="list-style-type: none"> <li>• Australian or New Zealand passport; OR</li> <li>• Australian birth certificate and a form of photo identification; OR</li> <li>• evidence of Australian citizenship <b>AND</b> a form of acceptable photo identification (outlined above); OR</li> <li>• certificate of Status for New Zealand citizens in Australia <b>AND</b> a form of acceptable photo identification (outlined above).</li> </ul> To confirm Australian <u>permanent resident status</u> , you need to upload a copy of one of the following: <ul style="list-style-type: none"> <li>• certificate of Australian permanent resident status <b>AND</b> a form of acceptable photo identification (outlined above)</li> <li>• a passport issued by the government of another country along with a check using Visa Entitlement Verification Online (VEVO).</li> </ul> If you do not have any of the above documents you can apply to <a href="#">Department of Home Affairs</a> for Evidence of Australian Citizenship or Certificate of Evidence of Resident Status. <b>You must upload evidence with your application – additional documents will not be accepted after applications have closed.</b>
4) Candidates who are temporary visa holders or overseas candidates who require a visa to work in Australia	A copy of: <ul style="list-style-type: none"> <li>• The official Department of Home Affairs grant notification (not a document that is cut and pasted into a word document or notepad) <b>AND</b></li> <li>• Copy of your current passport with identifying features (photo page)</li> </ul>
